Cleansing Notice

For the purposes of Section 708A(5)(e) of the Corporations Act 2001, Discovery Alaska Ltd (the "Company") hereby provides notice that pursuant to its ASX announcement dated 24 August 2026 and Appendix 2A dated 31 August 2026, the Company has issued 6,585,000 Ordinary shares at \$0.009 per share, to raise \$59,265.

The Company hereby notifies ASX under paragraph 708A(5)(e) of the Act that:

- (a) the Company issued these Securities without disclosure to investors under Part 6D.2 of the Act;

 - ii. the rights and liabilities attaching to the Securities.
