## QUARTERLY ACTIVITIES REPORT March 2025

---

Discovery Alaska Limited (ASX: DAF) ("the Company") is an Australian based mineral exploration company with a binding Mining Lease Agreement for the 100% rights to the Vinasale Gold Project in Alaska, USA and a 100% interest in the Chulitna Project in Alaska, USA.

The Company provides the following update for the Quarter;

### **Exploration Activities**

#### ***New Project Opportunities***

The Company is currently working to identify and review new projects or asset acquisition opportunities, to enhance its project portfolio with an aim to increase the overall value proposition of the Company and ensure it is best placed to deliver value and upside potential for all its shareholders.

During the Quarter, the Company reviewed various mineral project opportunities and conducted due diligence over projects that may complement the Company's current exploration activities. Following completion of any successful project due diligence exercise and pending strategy determined, the Company will consider any such opportunities and progress as required.

#### ***Vinasale Gold Project***

The Project comprises ~6,500 hectares and is located ~310 km northwest of Anchorage and ~26km south of McGrath, on lands owned by Doyon, Limited - an Alaska Native Regional Corporation. The Company is completing a review to determine its strategy for the project.

#### ***Chulitna Gold Project (Alaska, USA) (100% interest)***

The Chulitna Project is located on State of Alaska public lands, and is not subject to any Native Title claims, native lands, or native claimant groups. The project lies approximately 250km north of Anchorage and close to the major Parks Highway, which runs mostly parallel to the State-owned Alaska railroad. The project area comprises 15.5km<sup>2</sup> (24 claims) centred on the Partin Creek gold prospect. The Company is reviewing its strategy for the project.

### **Corporate**

The Company currently has cash reserves of ~\$0.3 million (as at 31 March 2025), and will maintain prudent financial management.
